## Eligibility Requirements and Selection Criteria

The application process is open to all first-year law students enrolled full-time and in good standing at an ABA-accredited law school.

A selection panel will evaluate all applications, considering the factors below:

- Demonstrated academic performance and leadership achievements.
- Significant personal achievements and strong community involvement.
- Demonstrated commitment to promoting diversity, inclusion and equity in the legal profession and/or community.
- Sincere interest in practicing at a top civil litigation firm.

Students may apply through our website starting November 15. All applications are due by January 31.
